7	This Memorandum of Understanding (MOU) sets forth the following Agreement between the			
8	Washington Federation of State Employees, AFSCME Council 28 (The "Union") and Eastern			
9	Washington University (The "University") regarding the extension/roll-over of the 2019-2021			
10	Collective Bargaining Agreement. This MOU shall be attached to the 2021-2023 CBA.			
11				
12	The parties agree that the terms and provisions of the 2019-21 agreement, including the current			
13	salary schedule, will continue unchanged in the 2021-23 Collective Bargaining Agreement			
14	except as detailed below:			
15				
16	• The title page and "footers" of the CBA shall be amended to reflect the proper term of			
17	this CBA (2021-2023). The CBA signature page shall be amended to reflect current			
18	Bargaining Team members and signees			
19				
20	• Regarding the Police Department: Due to the Tentative Agreement reached between the			
21	Union and the University establishing a separate agreement for Uniformed Personnel			
22	effective July 1, 2021, all references to uniformed personnel will be void upon expiration			
23	of the '19-'21 CBA at midnight, June 30, 2021. As all references are void, they are			
24	therefore also removed from the '21-'23 contract.			
25				
26	Both the Union and the University recognize the Uniformed Personnel's independent			
27	CBA as the governing document containing all negotiated provisions for those			
28	employees, beginning July 1, 2021.			
29				
30	 Article 19.1 Base Wages Increases of the CBA shall be amended to read as follows: 			
31				
32	19.1.1 For the term of the current Agreement (July 1, 2021 - June 30, 2023) only, the			
33	University agrees to pass through at the rate of 100%, any legislature funded			
34	salary increases or COLAs to all job classes covered by this CBA. Any increase			
35	will be applied no later than the date the legislature indicates the increase take			
36	effect.

38	19.1.2 Classified employees subject to this Agreement who are employed with the			
39	University on July 1, 2021 will receive a one hundred dollar (\$100) signing			
40	payment on the July 25, 2021 pay day.
