Curriculum Development:

PHED 596 (Survey Research): In the winter quarter of 2010, Dr. Chadron Hazelbaker and I planned and implemented a graduate level course, which was designed to provide students with a framework for understanding various aspects of the creation, implementation, and basic statistical analysis of survey research. This class has been submitted, via the university process, for curriculum adoption in the PEHR Masters of Science Degree in Sports and Recreation Administration.

RCLS 497 (now RCLS 330) (ACA Intermediate Whitewater Kayaking): In fall of 2008, Dustin Semb (EPIC) and I planned and implemented an experimental four-day, intermediate whitewater kayaking class. The class was designed for both EWU students and members of the community who are looking for additional instruction beyond the beginner format. The class was held in the classroom and on the Spokane River for one day. The remaining three days of instruction were conducted on the Salmon River, near Riggins, Idaho. The skills and information taught in this course emphasized judgment and decision-making; group leadership techniques; environmental stewardship; intermediate paddling techniques; on-water scenarios to assess whitewater features and risk; and principles of safety and rescue for individuals and groups. In fall quarter of 2009, RCLS 330 (formally RCLS 497) became an elective class in the RCLS Outdoor Recreation curriculum.

RCLS 313 (Wildland Recreation Management): In fall of 2006, RCLS 496 (Wilderness Education and Awareness) was formally adopted in the RCLS curriculum under a new course number and name (RCLS 313: Wildland Recreation Management). In fall of 2007,

RCLS 313 became a core class in the RCLS curriculum, as dictated by the NRPA Council on Accreditation.

PHED 496 (Wilderness Education and Awareness): The product of a \$6,000.00 Teaching and Learning Center Grant (EWU), this three-credit course was multi-faceted in nature. Our first goal was to have PE and RCLS students work together. As a result of taking this course, we wanted PE students to bring lifetime leisure activities into the classroom. In addition, RCLS students gained experience with pedagogy and classroom instruction. Second, we wanted to instill a sense of stewardship toward wild places and natural resources in the United States. Third, students became certified as Leave No Trace Trainers (a National Outdoor Leadership School Certification). Last, students took this training into a service-learning project with K-12 students in the Spokane Public School District. Dr(s) Chase and Morley taught this course collaboratively in the fall of 2004.

YMCA High Ropes Certification Course: (April 2003 & 2004) In coordination with the YMCA of Spokane, the RCLS department offered a five-day high ropes certification course for majors. In total, twelve students participated (the course included over 50 hours of instruction). The course was residential and took place at Camp Reed, which is located 50 miles north of Spokane.

RCLS 465 (Travel and Tourism): In winter of 2004, RCLS 499 was formally adopted into the recreation management curriculum under a new course number and name (RCLS 465: Travel and Tourism). This course serves as a senior level seminar that addresses current issues, challenges, and trends seen in the travel and tourism industry. Students also plan, implement, and evaluate a five to seven-day field trip to a west coast destination (usually a city or location known for its travel and tourism industry). To date, students have visited Bend, OR; Portland, OR; Vancouver, BC; Banff, AB; Las Vegas, NV; Lake Tahoe, CA; and Moab, Utah. Students conduct site visits and management tours over a three to four-day period.

RCLS 499 (Spring Break Commercial Recreation Tour of Central Oregon): Offered March 2002 and 2003.

RCLS 496 (Northwest Outdoor Leadership Challenge): Co-taught during the summers of 2001 and 2002 with David Early. Course activities included backpacking, rock climbing, and whitewater rafting in remote locations, e.g., Montana and Central Idaho (over a five-day period).
