Wages Summary

Recreation Lead @ \$14.43/hr x 2,975hrs = \$44,646 Recreation Specialist @ \$13.74 x 1,558hrs = \$22,263 Recreation Assistant @ \$13.50 x 3,827hrs = \$53,731

The awarded funding in wages was reduced from FY19 to FY20 by ~\$20,000. As a result, EPIC investigated the options of hiring work-study positions in order to continue meeting the demands of service from student customers. These customers request that EPIC be open early in the morning (8:30am) in order for equipment rentals to be returned before students attend classes. The customers also request that EPIC be open in the evening (6:00pm) to pick up these rentals after their classes have ended. If the awarded funding amount is below the requested level, EPIC will re-explore work-study positions as a method to be customer service demands. If work-study positions are not available, EPIC will then need to evaluate reductions in service, and limit hours of operation. The FY21 request is near (though still below) the amount awarded to EPIC in FY19.
