a) Art Gallery

- i) Option 1: Recommend \$1,500 across the board, based on previous years they have not used all allocated funds
- ii) Option 2: at 10% increase raise it up to \$1,800
- iii) A motion to keep the allocation at \$1,500 at all percentages (0%, 2.2%, 5%, 7%, 10%) increase was made, seconded; Motion passes unanimously 8-0-1.

 - ii) A motion was made to allocate option 1, seconded; Motion passes unanimously
- r) Music Department
 - i) Option 1: \$15,000 for 0%, 2.2%, 5%, 7% and up to \$30,000 for 10%
 - ii) Option 2: \$15,000 for 0% and 2%, \$18,000 for 5%, \$20,000 for 7%, and 10% is \$30,000
 - (1) Can make a note that funds not be used for instrument replacement
 - **iii)** A motion was made to extend the time by five minutes, seconded, motion passes unanimously.
