    - a. Questions and Concerns
      - 1. The money requested this year had a large increase from the money that was requested last year.
        - Due to a loss of a donor, the money has increased. The money that has been received from the Provost cannot be used for food.

Therefore, the money that is requested from this committee will be going towards the food and/or the items to be given away.

 The money reserved for giveaway items is a large request The committee discussed if there was a way that we could confirm that only the faculty and presenters received shirts, bags and food from the symposium.

The committee also discussed the possibility of limiting what they were going to give away at the event. They discussed perhaps there wouldn't be giveaway-bags and instead they would only giveaway the t-shirts.

- 6. EWU Childcare Center
  - a. Questions raised
    - **1.** What will the fees that students pay be used for?
      - EWU contracts the responsibilities of the childcare center to be ran by the YMCA. Those responsibilities include having their own staff that are paid through the YMCA.

EWU owns the building that the childcare center is in and EWU owns the washer and dryer.

The fees go towards the money needed for the upkeep on the building as well as the washer and dryer. And the fees go towards supplementing the costs for the students to use the childcare Center to make it more affordable for the students who need to use it.

A rate sheet that compares EWU's childcare costs with other schools and institutions will be provided at another meeting. This sheet will help inform on how the supplementation of the student fees are helping towards affordable childcare.

 How are the contract rates affected? The rates of the contract with YMCA do not increase with the increase of students with children in the day care. There is a flat rate for students.
