

## Certification of Finances for International Students

Immigration law requires that all F-1 and J-1 visa applicants provide proof of funds/financial support (available money) for at least one full year of study. Complete this form and return it to the EWU School of Global Learning along with the required accompanying documents or statements noted in the Funding Details section. Financial documents and statements may not be more than six months old at the time of submission.

### Funding Details

Enter the name(s) of the people or agencies who will be paying your expenses. The information provided must match the name on the certified bank or sponsor letter. **Enter all amounts in U.S. dollars only.** Use an additional sheet of paper for explanations if necessary.
